President's Message:

We are currently experiencing our first taste of winter and if you are like me, some of our thoughts move to thinking about the cottage.

What is going on at Big Gull? Do we have ice on the lake? How low is the water? Do we have a snow cover?

Our green 2015 Xmas certainly reinforced the message of global warming and its accompanying effects: general warming of the lake, consequent climate change for our fish species; a decline in optimum environment for cold water fish like pike and pickerel, an enhancement in the environment for warm water fish species like small mouth bass and crappie; increased potential for aquatic invasive species; low snow cover for amphibians winter survival; through to the very white snow shoe rabbit running around in a green setting looking decidedly out of place.

Looking back at 2015, some of the more influential happenings for seasonal residents related to energy. Ontario Hydro has already increased the rates significantly for low users and the 10-year forecast is for more to come. Our local municipality (with a strong lobby from local Lake Associations) stood up to a Wind Farm proposal from a firm that has little respect for cottage country. Currently, our council is favourably inclined to supporting solar farms.

On our lake, we welcomed the return of the Kid's Fishing Derby and many thanks go the Jeff Burzynski and Jennifer Bell and volunteers. They look forward to your continued support next year. We also ran a very successful BGLEECA Golf tournament organized by the husband and wife team of Jim and Joyce Kuhr, a triathlon run by the Commerfords' and Nancy Gibson, and the Annual Sail Boat Regatta with Norma and Bill Hindson coordinating. Water sampling was carried out by Bev Williams and Virginia Grant, and our Lake Steward, Lynda Corkum, was instrumental in organizing a Loon Survey on the lake (see report below).

For 2016, we welcome the addition of a new director at large, Keith Rowe, otherwise known as a keen fisher. He will be coordinating all things linked to "Communication" and has produced a Kids' Newsletter *LISTEN*, *LOOK AND LEARN* to encourage the interest and involvement of our younger cottagers (see attachment to this newsletter).

Looking ahead, I see continued financial challenges for Ministries and other organizations that are of interest and benefit to cottagers: the Ministry of Natural Resources, the Ministry of Environment, and Conservation Authorities such as the Mississippi Valley Conservation

Authority. Their ongoing cutbacks will impact flood control, water quality monitoring, invasive species monitoring, shoreline management, water level management etc..

Dark Sky Proposal and North Frontenac Wind Farm

A CBC Report published in June, 2015 noted that the Royal Astronomical Society of Canada designation of a Dark Sky Preserve in North Frontenac has no protected status. This project may be hugely impacted by the proposal to install approximately 200 industrial wind turbines, whose strobe lights (necessary for aircraft safety) would cause so much light pollution that the dark sky area designation would be rendered pointless. North Frontenac's Dark Sky Reserve is one of only 13 such-identified sites across the country, and one of the closest to major urban areas. This is an important place for Canadians to see the night sky as it was meant to be seen.

Aside from the negative impact to the Dark Sky Reserve, the wind farm proposal remains a sore point. The North Frontenac Township voted 7-0 against a wind farm in the area, but the municipality's vote can be overruled by the provincial government.

What is FOCA and why we are members?

FOCA is the Federation of Ontario Cottagers' Association. Big Gull Lake East End Cottage Association (BGLEECA) is one of 510 associations and 50,000 families that are represented by FOCA. Lynda Corkum, who is the BGLEECA Lake Steward, serves as one of ten volunteer Directors of FOCA. Ken Grant, President of BGLEECA, is also President of FOCA.

The mission of FOCA is to *protect thriving and sustainable waterfronts across Ontario*. Nice mission statement, but what does it mean for us? The answer is that FOCA can influence decision-makers when individuals cannot. FOCA helps cottagers throughout the province to enhance water quality, boating safety, fair taxation and sustainable waterfronts.

Here are some highlights of FOCA activities:

- The advocacy group of FOCA has worked with the Ontario Energy Board to negotiate reductions in electrical bills for seasonal residents (cottage owners). Yes, electrical bills will increase soon, but the increase will be significantly less than it might have been, thanks to the efforts of FOCA.
- FOCA has responded to Environment Canada and the US Environmental Protection Agency to argue for increased monitoring of rivers to track nutrients that run off from the land into the Great Lakes.

- FOCA collaborates with conservation authorities, the Ministry of Environment and Climate Change (MOECC), the Ontario Federation of Anglers and Hunters, and others, to help monitor our lakes for invasive species and nutrients, alerting us to problems that can be addressed. FOCA is doing such a stellar job in the area of enhanced water quality and management of Ontario lakes that in November 2015, the international organization North America Lake Management Society gave FOCA the "Leadership and Service Education and Outreach Award."
- In October 2015, FOCA along with the Ontario Onsite Water Association took MOECC to task for allowing a resort to release septic effluent directly into Muskoka Lake. FOCA is demanding action to resolve this issue.
- Visit the FOCA website (<u>www.FOCA.on.ca</u>) to see all sorts of helpful information available
 to members, including a Shoreline Owners Guide to Healthy Waterfronts, fact sheets and
 videos on invasive species, noise, pollution prevention, docks, safety tips on wood stoves, our
 night skies, and more. Members also have had access to a webinar on cottage ownership
 transfers.
- Because our lake association is a FOCA member, we are eligible to receive a bi monthly electronic newsletter called "ELERT". To set up your account, go to (www.FOCA.on.ca) and register now.
- Reduced group rates for cottage, auto, and boat insurance are available through FOCA. These
 reduced rates are not available to individual applicants. Membership also entitles us to a
 discount for Cottage Life magazine.
- FOCA Executive Director, Terry Rees, and staff, Michelle Lewin and Deanna Panitz, work tirelessly. Ken and Lynda have visited the small FOCA office in Peterborough. We can't envision a more productive, efficient and helpful team, working on our behalf.

We pay \$30 for our Big Gull Lake East End Cottage Association fees. Of this, \$3.25 goes toward FOCA. What a deal!

North Shore Road Report

Last year a lot of time was spent to grade our road system. With the addition of a Tractor with a grader blade on the rear three point hitch, roads were kept in good condition. Also Spencer Robinson of Robinson Excavating delivered one of his road graders to me and I had the use of it most of the summer. Any bad spots could be repaired easily. Some new gravel was applied to the end of Marshview Drive, a section that had not received white gravel in the past. As of now, all roads that are maintained by the North Shore Road manager have had at least 1 application of white gravel. Clearing the sides of #10, both Belchams and part of Mosquito Lake Parkway has improved the looks of these roads. Clearing will continue in 2016 until funds run out. Beavers started to show their skills at the start of the 2015 season, but I was able to control the problem. The culvert screen at the end of Mosquito Lake was plugged up with leaves, not beaver-related. I cleaned the culvert screen on Dec 13, 2015.

I believe we have some of the best maintained cottage roads in our area, and with continuing maintenance and controlled speed, our North Shore Roads will be something we can be proud of for many years into the future.



Big Gull Lake East End Cottage Association 2015 Loon Survey

This year, volunteers on Big Gull Lake participated in the Canadian Lakes Loon Survey (Table 1). The survey on our lake is one of many conducted across the country to determine the reproductive success of loons. Surveys are coordinated by Bird Studies Canada. Volunteers surveyed loons in early June (when loons establish territories), in mid-late July (when chicks hatch) and in late August (when young have reached more than half the size of an adult). Some volunteers reported observations at other times as well. The survey will determine how many young will survive to migrate south.

The Common Loon feeds on fish and because the loon is high in the food chain, the bird is a good indicator of lake health. Results of loon surveys across Canada have shown that loon reproductive success increases with lake size. However, acid participation (not a problem on Big Gull Lake) results in a decline in fish on which loons depend. Acid conditions also increase the availability of methyl mercury. High levels of human activity and development may negatively affect loon nests. Adults are long-lived (up to 20 years) and often return to the same breeding territory each year.
